- 4.371 **24/00054/HOU** Installation of flush PV panels into outbuilding slate roof at West Lane House, West Lane **permitted**
- 4.372 **24/00022/LBC** Listed Building Consent for the proposed installation of flush PV panels into outbuilding slate roof at West Lane House, West Lane **permitted**
