THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (PUBLIC BRIDLEWAY
NUMBER 18A, PARISH OF EMBERTON) DEFINITIVE MAP MODIFICATION ORDER
2017

The above Order made on 9th November 2017, if confirmed as made, will modify the definitive map and statement for the area by adding to them the bridleway from point A on the map on the west end of the Petsoe Manor farm yard at O.S. grid reference SP91008/49461 the route heads generally easterly direction for 111 metres to point B at O.S. grid reference SP91116/49476 on the said map, then south east for 21 metres to point C at O.S. grid reference SP91137/49458, then travels in a south easterly direction for 169 metres to point D at O.S. grid reference SP91179/49302 where it then heads generally north east to point E at O.S. grid reference SP91411/49371 for 253 metres as shown by a broken black line with short intervals on the map. The route then travels east for 66 metres to point F at O.S. grid reference SP91477/49369 and continues in a generally south easterly direction for 454 metres to point G at O.S. grid reference SP91912/49262 where it links to Bridleway 18, Parish of Emberton. Between points E and G on the map the route overlaps with the existing Footpath 17, Parish of Emberton as shown by a broken black and red line with short intervals on the map annexed hereto. The current status of this footpath will be upgraded to bridleway. The new bridleway to have a width of 3.5 metres from point A to point B on the map and then 3 metres to point G on the map. The surface is made up Macadam Tar Chip/hardstanding.



Any representation or objection relating to the Order must be sent in writing to the Head of Legal Services, Milton Keynes Council, Civic Offices, 1 Saxon Gate East, Milton Keynes, MK9 3HG, quoting reference PE-015014-EG , to be received not later than 22nd December 2017, stating the grounds on which it is made.

If no representations or objections are duly made to the Order, or if any so made are withdrawn, the Council of the Borough of Milton Keynes, instead of submitting it to the Secretary of State, may itself confirm the Order. If the Order is submitted to the Secretary of State, any representations or objections which have been duly made and not withdrawn will be sent with it.
